### IV. Policy and Procedure Items

- 1. On September 8, 2021, EPC approved the Standing Committee Expectations for the 2021-2022 academic year.
- 2. On September 22, 2021, EPC approved revised General Education student learning outcomes for Section C: Arts, Humanities, and U.S. History. The student learning outcomes were approved by the Faculty Senate on February 17, 2022.
- 3. On November 3, 2021, EPC approved revised General Education student learning outcomes for Section B: Scientific Inquiry and Quantitative Reasoning. The student learning outcomes were approved by the Faculty Senate on February 17, 2022.
- 4. On November 3, 2021, EPC formed a subcommittee to provide clear guidelines on the committee's expectations for sample syllabi. The subcommittee provided an update and asked for feedback on December 1, 2021.
- 5. On November 3, 2021, EPC formed a subcommittee to streamline requirements to simplify the curriculum proposal process.
- 6. On November 17, 2021, EPC started discussing General Education recertification/assessment. It was announced on May 4, 2022 that a pilot is underway to assess GE sections A1: Oral Communication and A3: Critical Thinking, with a product anticipated for EPC review in Spring 2023.
- 7. On December 1, 2021, EPC approved revisions to the Academic Internship policy. (Joint policy with the Graduate Studies Committee.) The policy was approved by the Faculty Senate on March 10, 2022.
- 8. On February 2, 2022, EPC approved changing the term *academic probation* to *academic notice*.
- 9. On February 2, 2022, EPC approved revisions to the instructions on the Course Alignment Matrix and Course Objectives Chart as well as the abridged matrices for listing across GE sections.
- 10. On February 16, 2022, EPC approved continuing the Matador Academic Challenge pilot for first-time freshmen and first-time transfers in the 2022-2023 academic year.
- 11. On March 2, 2022, EPC reviewed proposed revisions to the Major/Minor policy related to double majors and options in the same department. On May 4, 2022, it was announced that the proposed revisions will be updated over the summer and the policy recommendation will return to EPC next academic year.
- 12. On March 2, 2022, EPC approved the Undergraduate Institutional Learning Outcomes. The institutional learning outcomes were approved by the Faculty Senate on May 5, 2022. A Faculty Learning Community will develop Justice, Equity, Diversity, and Inclusion (JEDI) standards next academic year.

- 13. On March 16, 2022, EPC approved a pilot program allowing Mike Curb College of Arts and Communication freshmen to delay enrolling in B4 Mathematics and Quantitative Reasoning until the second year.
- 14. On April 6, 2022, EPC approved revisions to the Policy on Discontinuance of Programs. (Joint policy with the Graduate Studies Committee.) The policy recommendation was considered for a first reading by Faculty Senate on May 5, 2022 and will return for a second reading during the 2022-2023 academic year.
- 15. On April 6, 2022, EPC formed a subcommittee to clarify EPC's expectations for proposals submitted under the B5 SLOs. The subcommittee provided an update on April 20, 2022 and asked for feedback on May 4, 2022. The subcommittee's recommendations will be discussed at the Fall 2022 EPC member retreat.
- 16. On April 20, 2022, EPC approved removing references to the Upper Division Writing Proficiency Exam (UDWPE) from the 2022-2023 University Catalog. The committee also reviewed proposed revisions to the Graduate Writing Assessment Requirement (GWAR) policy. The policy recommendation will return to EPC next academic year.
- 17. On May 4, 2022, EPC reviewed the proposed ESAC/EPC workflow to ensure that the ESAC review and approval process is finalized prior to agendizing Ethnic Studies designation courses at EPC.
